
Collin Home Health Care is a full service health care agency dedicated to providing the highest quality of in-home medical care in your community.

Government studies have shown that home health care clients live longer and report a greater quality of life.


Privacy




PHYSICIAN DIRECTED

Our agencies never initiate service for a client without prior approval by the attending physician. After consultation with the Collin Home Health Care medical staff, a client's doctor will prescribe an ongoing program for medical monitoring, treatment, or therapy.

Thereafter, our skilled nursing professionals



maintain regular and frequent contact with client physicians to provide updates and receive additional instructions. We all work as a team for the sake of our client's continued health and wellbeing.
